Supplement to article 16 of the ITHF Constitution

Information

COVID-19 showed that sometimes there are situations when it is necessary urgently to make some decisions (cancellation or transfer of tournament, etc.). The Executive Committee of ITHF now does not have such opportunity to make the necessary decision quickly. Article 16 of the ITHF Constitution is therefore proposed to be supplemented by paragraph 16.6.

Question

Article 16 of the ITHF Constitution is proposed to be supplemented by paragraph 16.6:

"16.6 The Executive Committee has the right to make decisions about all topics under special circumstances, such as cancelling tournaments, changing the ITHF WTHT, moving international championships etc."
